Park Bench, Picnic Table, Tree & Public Art Sponsorship Program

Purpose

The Village of Nyack's Sponsorship Program provides residents, organizations, and businesses an opportunity to support the enhancement and maintenance of Village parks through voluntary donations.

Eligible Sponsorships

Subject to Village approval and availability, sponsorships may include:

- Park benches
- Picnic tables
- Trees
- Public art or sculpture

The Village retains sole discretion over the type, location, installation, and placement of all sponsored items.

Recognition

Sponsors may be recognized with a standardized plaque approved by the Village. Plaques may include only a name or brief dedication. Recognition is limited to deceased individuals with meaningful ties to the Village, or to local businesses, nonprofit organizations, and civic groups.

Fees

Contribution amounts shall be established by the Board of Trustees and reflect the cost of purchase, installation, and administration. Sponsorship funds shall be used for park maintenance, improvements, or other public purposes.

Village Rights

All sponsored items remain Village property. The Village may repair, relocate, replace, or remove any sponsored item as necessary for maintenance, safety, park improvements, or operational needs without refund or replacement.

Administration

The Village Clerk shall administer the program and execute sponsorship agreements in a form approved by the Village Attorney.

Sponsorship Contribution

The Sponsor agrees to make a one-time, non-refundable contribution in accordance with the Village's current fee schedule (Exhibit A). Payment is due prior to installation.

Recognition

The Village will provide a standardized plaque bearing approved wording consisting only of a name or brief dedication. Final approval of all wording, materials, size, and placement rests solely with the Village.

Ownership

This sponsorship is a charitable contribution only. It does not convey ownership, naming rights, exclusive use, or any other property interest in Village property.

Village Authority

The Village may install, maintain, repair, relocate, replace, or remove the sponsored item whenever deemed necessary for public purposes, including maintenance, safety, redesign, or operational needs. No refund or replacement shall be required.
